Management Discussion and Analysis

Macro-economic Review and Outlook

While global growth is expected to remain modest at 3.1% in 2026 and 3.2% in 2027 amid elevated uncertainty, India's outlook remains comparatively strong. According to the IMF, growth for 2025 is revised to 7.6% and projected at 6.5% for 2026 and 2027, supported by domestic momentum. Risks persist, but fundamentals remain supportive of continued resilience.

Global outlook: The global economy is facing renewed headwinds, with the outbreak of war in the Middle East adding to existing macroeconomic pressures. Rising commodity prices, firmer inflation expectations, and tighter financial conditions are weighing on the resilience observed in recent periods. Assuming the conflict remains contained in scope and duration, global growth is projected at 3.1% in 2026 and 3.2% in 2027, below recent outcomes and well short of pre-pandemic averages. Growth in the euro area is expected to moderate, with GDP projected at 1.1% in 2026 and 1.2% in 2027, reflecting a gradual slowdown from earlier momentum, as the impact of the conflict, alongside elevated energy prices and currency movements, weighs particularly on the manufacturing sector. Global inflation is expected to increase modestly in 2026 before resuming its decline in 2027, with pressures concentrated in emerging market and developing economies, particularly among commodity importers. The outlook remains subject to downside risks, including a prolonged conflict, greater geopolitical fragmentation, weaker productivity gains, and renewed trade tensions, compounded by elevated public debt and constrained policy buffers (IMF World Economic Outlook, April 2026).

India Story: According to the Reserve Bank of India, India's real GDP growth is projected at 6.9%, reflecting resilience despite global shocks and supply-side uncertainties. Inflation is projected at 4.6%, with risks from energy prices and weather disruptions, while liquidity remains adequate, supporting stable funding conditions and credit flow. The external sector stays resilient, and the RBI maintains measured optimism while remaining ready to act as conditions evolve. The RBI signals cautious optimism, while remaining prepared to act if conditions evolve.

The RBI envisages a landscape of steady, resilient growth and anchored inflation, supported by stable financial conditions and resilient domestic demand. A supportive liquidity environment is expected to sustain credit expansion, strengthening the growth trajectory of the broader economy, with positive implications for the housing finance sector.

Industry Overview

The Indian housing finance sector continues to expand at a measured and durable pace. Individual housing loans stood at ₹37.18 lakh crore as of September 2025, reflecting growth of ~9.5% year-on-year, with the portfolio estimated at ~₹39 lakh crore for FY26 based on available industry trends. Disbursements have remained steady, reaching ₹8.4 lakh crore by February 2026, indicating continued strength in origination activity.

The sector's footprint in the economy has increased, with the housing loan-to-GDP ratio rising from 8.0% in FY15 to 11.23% in FY25. Even so, mortgage penetration remains below that of peer economies, suggesting further room for expansion.

House prices have continued to firm, with the index published by National Housing Bank recording a 4.8% increase in Q2 FY26 across major cities, pointing to underlying resilience in demand supported by urbanization and demographic shifts.

Policy settings have remained supportive. Government initiatives such as Pradhan Mantri Awas Yojana (PMAY) and the Urban Infrastructure Development Fund have continued to catalyze housing demand and improve infrastructure in Tier II and Tier III markets. In parallel, adjustments to priority sector lending norms by the Reserve Bank of India have broadened the reach of formal housing finance. Advances in digitization, underwriting, and data availability are further improving the efficiency and transparency of credit delivery.

Conditions in the sector remain constructive. Growth is supported by underlying demand, though the outlook will depend on broader macroeconomic and financial developments.

Affordable Housing :A Strategic Growth Driver

Affordable housing remains a key structural driver of growth, supported by sustained urbanization, improving income mobility, and continued policy support. With over 500 million people currently residing in urban areas, expected to rise to ~590 million by 2030, demand remains deep and enduring. Despite this, EWS and LIG segments account for only ~35% of HFC portfolios, indicating significant headroom for expansion.

Affordable Housing Finance Companies are uniquely positioned to capture this opportunity. AHFCs, with their specialized underwriting frameworks, doorstep service models, and deeper penetration into Tier II and III geographies, are best placed to serve these markets reaching salaried individuals without formal income documentation, self-employed micro-entrepreneurs, and first-time homebuyers stepping into formal credit for the very first time. Government initiatives such as PMAY-Urban 2.0 and NHB-led refinance support continue to provide strong support.

At Nido, affordable housing is central to our purpose. With an average ticket size of ₹13 lakhs in FY26 disbursements and ~₹2,000 crore deployed in the affordable segment, we operate precisely where India's housing need is most acute, serving customers in Tier II and III cities who stand at the intersection of rising aspiration and limited access to formal finance. Through doorstep service, simplified documentation, and analytics-driven underwriting, we are bringing formal credit to those who need it most. We are confident that this focus will allow us to deliver both meaningful scale and lasting social impact, contributing to the vision of an inclusive and prosperous India.

Company Overview

Nido Home Finance: a focused affordable housing finance platform, positioned to scale with institutional strength and operating agility

Nido Home Finance caters to the housing finance needs of underserved low- and middle-income households through a well-diversified product suite, including home purchase, self-construction, home improvement loans, and loans against property. The Company also undertakes selective financing of developers within the housing segment.

The name 'Nido' is derived from the Sanskrit word “नीड़” (Nīd), meaning “nest” emblematic of the Company's core purpose of enabling safe and secure homeownership.

The Company operates through a network of 68 strategically located branches spanning high-growth urban centres, Tier I and Tier II towns, as well as key micro-markets within larger cities. Its hub-and-spoke distribution model, with branches acting as hubs and spoke locations extending reach, enables deeper market penetration and effective last-mile connectivity.

During FY 2025–26, the Company served over 22,000 customers, with Assets Under Management reaching approximately ₹4,900 crore, reflecting steady scale-up and an expanding customer base.

As on March 31, 2026, the home loans segment constituted ~61% of the retail loan portfolio, while other property loans accounted for ~39%.

Strategic Investment

During the year under review, the Company entered into an agreement to induct a new majority investor. The transaction between Edelweiss Financial Services Limited, CA Sardo Investments (an affiliate of The Carlyle Group) and Salisbury Investments Private Limited, the family office of Aditya Puri, comprises a secondary stake sale and a primary capital infusion of approximately ₹1,500 crore, as part of an overall investment of ~₹2,100 crore. Upon completion, the incoming investors are expected to hold a majority stake, subject to regulatory approvals and closing conditions.

This marks a significant milestone in the Company's evolution in being a trusted partner for low, middle, and informal-income entrepreneurs for their housing and home-equity finance needs. The investment will strengthen the capital base, bringing long-term institutional capital, and support in disciplined growth, with continued focus on asset quality, underwriting, and risk management. Further updates will be provided as the transaction progresses.

To support a higher growth trajectory, the Company undertook a set of targeted efforts and investments across technology, people, and processes during the year. These efforts are aimed at strengthening execution capabilities, improving operating efficiency, and build disciplined scale.

Strengthening the Operating Engine

Over the past few years, the Company has built a disciplined, execution-led operating model designed to scale in the affordable housing segment without compromising asset quality. This model is anchored in strong underwriting practices, field-driven distribution, and robust governance across credit and collections.

Field Capability and Distribution : Frontline execution has been strengthened through structured Branch Manager assessments, targeted capability-building initiatives, and calibrated expansion of the field force. Continuous training has improved sourcing quality, strengthened underwriting inputs, and enhanced on-ground productivity, particularly in serving self-employed and first-time homebuyers.

Collections Infrastructure : Collections has been reinforced as a core operating lever through the deployment of a dedicated collections management application and the strengthening of specialized collections teams. These interventions have improved visibility across delinquent accounts, enhanced prioritization and follow-up efficiency, and driven stronger resolution outcomes.

Asset Quality and Feedback Loops : Asset quality remains central to the operating framework. The Company has embedded hindsighting and feedback loops across sourcing, underwriting, and collections to continuously refine credit filters and identify early warning signals. This closed-loop system has enabled tighter control on portfolio quality while supporting growth.

Focused Affordable Housing Strategy : The Company's operating model remains anchored in the affordable housing segment, with investments across governance, distribution, underwriting, and field capability aligned to serve first-time homebuyers and self-employed customers at scale.

Technology and Analytics-Led Operating Framework

The Company continues to invest in a scalable, future-ready technology and analytics ecosystem to strengthen governance, improve execution discipline, and enable data-led decision-making.

A comprehensive suite of dashboards has been deployed to provide real-time visibility across origination, credit, collections, and portfolio performance. These dashboards act as a central governance layer, enabling structured reviews, faster decision-making, and accountability across levels.

On the sourcing and underwriting side, the introduction of pre-CIBIL checks has improved early-stage filtering, strengthened funnel quality, and reduced inefficiencies in credit processing.

In parallel, the Company continues to deepen its data and analytics capabilities across key areas, including underwriting scorecards, customer value management, operational efficiency, and risk and collections analytics. These initiatives are improving credit assessment consistency, reducing turnaround times, and enabling proactive portfolio monitoring.

Customer-Centric Approach

Customer centricity remains integral to the Company's operating philosophy. Product design and process development are informed by continuous engagement with customers through structured feedback mechanisms and research-led insights. This enables the Company to remain closely aligned with customer needs, particularly within the underserved and informal income segments, and to deliver solutions tailored to their financial requirements.

Foundation for Scalable Growth

The Company operates with well-defined processes that ensure clear segregation of responsibilities across sourcing, credit, operations, and collections. Standardized credit appraisal and risk management frameworks support consistent decision-making while maintaining portfolio quality. Robust monitoring systems across financial, credit, and operational parameters enable effective oversight and control of risk exposure.

The Company is governed by a strong and experienced Board, with Independent Directors bringing diverse expertise across financial services, administration, and law. The management team comprises experienced professionals with deep domain knowledge in housing finance and the broader financial services sector. The Company has continued to invest in building a scalable talent pool aligned with its long-term growth strategy, with employee headcount at approximately ~865 as of March 2026.

Our Product Portfolio

At the core of the offering is a range of mortgage-backed loan products that are designed to meet the diverse needs of our customers:

- **Home Loans** form the backbone of our business, enabling salaried and self-employed individuals to purchase, construct, or renovate their residential properties. These loans, secured against the property itself, account for 59% of our Loan Book as on March 31, 2026
- **Non-Housing Loans**, primarily Loans Against Property (LAP), are extended mainly to self-employed customers, secured against clear-title property assets. These loans help unlock capital for business expansion, property acquisition, or other personal or professional needs, contributing 21% to our Loan Book as on March 31, 2026.
- **Construction Finance** supports the building of residential projects, backed by strong collateral security. Disbursements are milestone-based, closely linked to the progress of construction. This portfolio comprises 13% of our Loan Book as on March 31, 2026.

Customer Profile

We continue to expand our reach among small-ticket, first-time borrowers, in line with the Government of India's 'Housing for All' initiative. Our focus remains on growing steadily while maintaining strong underwriting standards and a high-quality loan book.

New-to-credit customers form an important part of this strategy:

- 22% of retail customers sourced in FY25 had no prior credit history.
- As of March 31, 2026, new-to-credit borrowers made up 39% of our retail portfolio.

We believe **growth outside major metropolitan areas** will be a key driver over time:

- 68% of our loan accounts are from non-metro locations.

Self-employed customers, often overlooked by traditional lenders, are a segment where we see meaningful opportunity with prudent risk management:

- 53% of retail customers sourced in FY26 were self-employed.

Financial Highlights

During FY26, the Company disbursed loans totalling ₹17.55 billion and closed the year with an Assets Under Management (AUM) of ~ ₹49.06 billion. The gross credit book stood at ₹35.05 billion as of March 31, 2026.

Our fundamentals remain strong. We ended the year with a CRAR of 29.00%, a Net NPA of 1.9%, and a moderate leverage ratio with Debt-to-Equity at 3.7x. Standalone Profit After Tax for FY25 stood at ₹222 million. Return on Average Total Assets was 0.50%, while Return on Average Net Worth was 2.37%.

We maintain a diversified funding base across Term Loans from banks, NHB, Non-Convertible Debentures (NCDs), and securitization. In FY25, we raised ₹3.50 billion through term loans and ₹3.50 billion through market borrowings including NCDs. Over the same period, securitization transactions totalling ₹9.09 billion were completed with NBFCs and insurance companies.

Operating expenses was ₹2.02 billion, while finance costs were ₹3.48 billion. Asset quality and collection performance improved during the year. Collection efficiency remained robust at 99.5%. The total credit cost was ₹180 million for the year.

The Company's credit rating remains strong, with an A+ Stable rating from CRISIL.

Major Risk and Mitigation Measures.

A successful risk management framework can help a company achieve business objectives amidst changing business dynamics and macroeconomic environments in the volatility, uncertainty, complexity, and ambiguity (VUCA) world. At Nido Home Finance, our risk management is not just another function; it is an integral part of business strategy.

Respect for Risk is central to every business decision - "Is it worth it?" and "Can we afford it?". This principle-based approach has stood out well in protecting the organization from the vagaries of the external world.

Our robust risk management system enables us to identify, assess, monitor, and manage risks. It involves analysing potential risks, determining the likelihood and impact of those risks, and developing strategies to mitigate or manage them. The primary goal of risk management is to minimize the impact of risks on the operations, financial performance, and our reputation. It is an ongoing process that requires constant attention and adaptation to changing business conditions. We are committed to managing risk, balancing risk and rewards, and supporting the overall business objectives.

The Enterprise Risk Management (ERM) framework is followed for holistic risk management. The objective of the ERM framework is to look at the risks from all perspectives, not just credit or financial risks, and ensure that key risks are adequately and addressed in a timely manner. The organization has developed an in-house "Eleven-risk Framework" to ensure adequate focus on the key risks faced by the company: namely,

Market risk, Credit risk, Fraud risk, Operational risk, Physical & Infrastructure risk, Technology risk, Liquidity risk, People risk, Regulatory risk, Reputational risk, and Business risk.

Our credit risk framework ensures a prior and periodic comprehensive assessment of every client, counterparty, and the collateral. Exposure limits are sanctioned to counterparties based on their creditworthiness and pre-defined credit policy, duly approved by the board. The credit risk monitoring mechanism ensures that exposure to clients is diversified and remains within stipulated limits. Mindful assessment of the quality and quantum of collateral is key for a client limit.

The credit risk management framework typically includes identifying credit risks, establishing credit policies and procedures, underwriting, ongoing monitoring credit risk, mitigation of credit risk, reporting and management of credit risk, and improvement wherever required. Credit underwriting involves analysing financial statements, credit reports, and other relevant information to assess the borrower's loan repayment ability. Ongoing monitoring and improvement involves analysing data on credit losses, conducting regular risk assessments, and updating policies and procedures to reflect changes in the organization or the external environment.

The company has an elaborate Liquidity Risk Management framework. The pivot to the 'Asset Light' business model facilitates ALM risk management structurally. CLM (Co-Lending Model) and securitization are the key levers of the asset-light framework. Additionally, the asset-liability mismatch and collateral margins are regularly assessed. Liquidity requirements are closely monitored, and necessary care is taken to maintain sufficient liquidity for maturing liabilities and for any unforeseen requirements. Diversification in the sources of borrowing is ensured to reduce dependence on a single source. Operational risk is monitored by checking on metrics such as system downtime, fraud incidents, and operational losses to identify and mitigate operational risk. In addition to defining new processes, constant review of all critical processes is undertaken to proactively identify weak controls and strengthen the same. This helps us in ensuring compliance with governing laws. The business environment, increasing complexities, and sophistication of technology make us vulnerable to both internal and external fraud risks. The anti-fraud framework that emphasizes on proactive reporting and early detection of incidents is defined and implemented. Training and campaigns ensure that the employees are cognizant of this risk. More specifically, due diligence of borrower's income, KYC, and title reports is carried out strictly as per the policy to avoid fraud. The framework for fraud risk management typically includes assessment of fraud risk, development of fraud prevention policies and procedures, implementation of fraud prevention policies and procedures, detection and investigation of fraud incidents, response to fraud incidents and ongoing monitoring and improvement. The company is exposed to various changes in laws and regulations. Regularly realigning with the changed regulatory framework is the key to mitigating this risk.

Our risk management approach is three-pronged: Understanding the risk, taking timely and adequate risk management actions followed by strong risk oversight. The three lines of defence model enables a profound understanding to help take timely action with adequate governance mechanisms.

Further, the Risk Appetite framework guides the company in developing risk tolerances for strong risk oversight. Our risk appetite is reviewed periodically by the Board of Directors to ensure that it remains appropriate to the business objectives and risk environment. Across each risk vector, several Key Risk Indicators (KRI) are presented, supporting the risk appetite statements. The feasibility of the KRIs and thresholds is reviewed annually to consider potential changes in the underlying assumption used in defining such KRIs. This outlook on risk management has enabled the company to be a step ahead through environmental stress.

Our People

All significant audit observations and follow-up actions thereon are reported to the Audit Committee of the Board of Directors, which actively reviews the adequacy and effectiveness of the internal control systems and suggests improvements for strengthening the existing internal control system because of changing business needs. Based on the Internal Auditor's report, process owners undertake corrective actions in their respective areas and strengthen the controls.

Corporate Governance Philosophy

We firmly believe that exemplary corporate governance is pivotal to achieving this vision, we have therefore prioritized the implementation of robust practices across all aspects of our operations.

Outlook and Summary

Results from operations and Information on the state of affairs of the Company

During the year ended March 31, 2026, the Company earned revenues of Rs. 5,834.25 million as against Rs. 5,121.00 in the previous year and the Profit after tax for the year ended March 31, 2026 stood at Rs. 227.98 million as compared to a profit after tax of Rs.186.33 million in the previous year. Of the total income earned during the year, income from fees and commission stood at Rs. 506.74 million and income from lending activities stood at Rs. 4,504.15 million.

During the year under review, the loan sanctions (in-principal approvals) and the loan disbursements were Rs.33,632 million and Rs.21,138.72 million respectively.

The Company is primarily engaged in the business of providing loans and advances for housing activities. It is also engaged in soliciting and procuring insurance business as a Corporate Agent. During the year under review, there has been no change in existing nature of business of the Company.

Transfer to Reserves:

Out of profit for the year, Rs. 45.61 million has been transferred to special reserve under Section 29C of the National Housing Bank Act, 1987.

Transfer from Reserve

Pursuant to the provisions in the Companies Act, 2013 read with relevant rules thereunder, the Company being a Housing Finance Company is exempt from creation of Debenture Redemption Reserve in respect of NCDs issued during the year. In respect of public issuance of NCDs, the Company has invested 15% of the amount of debentures maturing during the corresponding financial year to maintain liquidity to fulfill its obligations arising out of debentures.

Dividend

The Company has paid Final Dividend of Re.0.35 per equity share of Rs.10/- each for the financial year 2024-25 during FY 2025-26 as approved by the shareholders at the 17th Annual General Meeting held on July 02, 2025.

As approved by the Shareholders at the 17th Annual General Meeting held on July 02, 2025, during the FY 2025-26, the Company has paid the Final Dividend of Re.0.35 per equity share of Rs.10/- each for the financial year 2024-25.

The Board of Directors have not recommended any dividend for the financial year under review.

Share Capital

As at March 31, 2026, Authorized Share Capital and Paid-up Share capital of the Company stood at Rs. 750 million and Rs. 693.5 million respectively. During the year under review, there was no change in the Authorized Share Capital and Paid-up Share Capital of the Company. All the Equity Shares representing 100% of paid-up equity capital were held in dematerialized mode.

Transfer of Shares

During the year under review, no share transfer requests were received by the Board of Directors.

Credit Ratings

The credit ratings enjoyed by the Company from various rating agencies as on 31st March 2026 are detailed in the Corporate Governance Report. The details of the changes in credit ratings, if any, are more particularly provided in the Notes to the Financial Statements and Corporate Governance Report.

Finance & Resource Mobilization

Our Company continued to borrow funds from Banks and various financial institutions in line with the Asset-Liability Management requirements.

During the year under review, the Company issued Secured Redeemable Non-Convertible Debentures aggregating to an amount of Rs.4,685.75 million through Public Issue.

The Company has been regular in making payments of principal and interest on NCDs. During the year under review, the Company has paid/redeemed Non-Convertible Debentures amounting to Rs.1,957.44 million on or before their respective due dates. As of March 31, 2026, outstanding Secured Non-Convertible Debentures stood at Rs.15,186.49 million.

Further, the Company has borrowing lines from Banks/ FIs which were available for the liquidity requirements of the Company. Apart from these, the Company assigned retail pool of mortgage assets amounting to Rs.745.20 crores.

In terms of para 68 of the Non-Banking Financial Company – Housing Finance Company (Reserve Bank) Directions, 2021, the total number of non-convertible debentures which have not been claimed by the investors or not paid by the Company after the date on which the non-convertible debentures became due for redemption were 649, and the total amount in respect of such debentures, which remained unclaimed or unpaid beyond the date referred hereinbefore was Rs.7,21,023.

Subsidiaries, Joint Ventures and Associate Company

Your Company does not have any Subsidiary or Associate Company, nor has it entered into any Joint Venture Agreement.

Loans, Investments and Guarantees

The Company is engaged in the business of providing loans and making investments as part of treasury activities, particulars of which are provided in the Notes to Financial Statements. Except as disclosed in the financial statements, during the year under review, the Company has not given any guarantee.

Updates post March 31, 2026

The Edelweiss Financial Services Limited (EFSL) and its wholly owned subsidiaries Edelweiss Rural & Corporate Services Limited (ERCSL), Edel Finance Company Limited (EFCL) and Nido Home Finance Limited (Nido) have entered into definitive agreements with CA Sardo

Investments (an affiliate of The Carlyle Group (NASDAQ: CG) and Salisbury Investments Private Limited (an investment vehicle of Aditya Puri and his family) (collectively, the Buyers) for an investment of approximately INR 2,100 Crores to acquire a strategic majority stake in Nido.

The Buyers will acquire a 45% stake in Nido from EFSL, ERCSL and EFCL (collectively, the Sellers), by way of subscription to equity shares and warrants of Nido. Upon completion of the sale and allotment of equity shares and warrants as contemplated under the transaction, the Buyers will hold approximately 73% of the shareholding of Nido on a fully diluted basis. Subject to receipt of requisite regulatory approvals and other customary closing conditions as stipulated in the Agreements, the transaction is expected to be completed by July 31, 2026.

Consequent to completion of the transaction, Nido will cease to be a subsidiary of EFSL.

1. Opinion

We have audited the accompanying financial statements of Nido Home Finance Limited ("hereinafter referred as the Company"), which comprise the Balance Sheet as at March 31, 2026, the Statement of Profit and Loss including Other Comprehensive loss, the Statement of Changes in Equity and the Statement of Cash Flows for the year then ended, and notes to the financial statements, including a summary of material accounting policies and other explanatory information (hereinafter referred to as the "financial statements").

In our opinion and to the best of our information and according to the explanations given to us, the financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the Indian Accounting Standards prescribed under Section 133 of the Act, read with the Companies (Indian Accounting Standards) Rules, 2015, as amended ("Ind AS"), and other accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2026, its profit including other comprehensive loss, its cash flows and the changes in equity for the year ended on that date.

2. Basis for Opinion

3. Key Audit Matters

Key audit matters are those matters that, in our professional judgment, were of most significance in our audit of the financial statements of the current year. These matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters. We have determined the matters described below to be the key audit matters to be communicated in our report.

As at March 31, 2026, the carrying value of loan assets measured at amortized cost, aggregated to Rs. 34,671.89 Millions (net of allowance of ECL of Rs. 365.32 Millions) In the process, a significant degree of judgement has been applied by the management in respect of following matters: • Defining qualitative/ quantitative thresholds for significant increase in credit risk' ("SICR") and 'default'. • Estimation of losses in respect of loans or groups of loans which had no/ minimal defaults in the past. • Grouping of borrowers based on homogeneity by using appropriate statistical techniques. • Staging of loans and estimation of behavioral life. • Determining macro-economic factors impacting credit quality of receivables. The Company has developed models that derive key assumptions used within the provision calculation such as probability of default (PD) and loss given default (LGD). The output of these models is then applied to the provision calculation with other information including the exposure at default (EAD).	Our Audit Approach: Our audit approach was a combination of test of internal controls and substantive procedures which included the following: - Evaluated the Company's policy, as approved by the Board of Directors, for impairment of carrying value of loans and advances and assessing appropriateness of the Company's impairment methodologies as required under Ind AS 109. - Obtained and reviewed reports relating to the independent "Back testing" and Model refresh exercise annually carried out by the Management. - Tested the operating effectiveness of the controls for staging of loans based on their past-due status. Tested a sample of performing (stage 1) loans to assess whether any SICR or loss indicators were present requiring them to be classified under stage 2 or 3. - Assessed the additional considerations applied by the management for staging of loans as SICR. - Tested the ECL model, including assumptions and underlying computation. De-recognition of financial assets (Assignment Sale) The Company has, during the year ended March 31, 2026, derecognised loans amounting to Rs. 7,452.04 Millions and recorded net income of Rs. 616.61 Millions in the Statement of Profit and Loss. In accordance with Ind AS 109, de-recognition of financial assets (loans) transferred by the Company through assignment is based on the 'risk and reward' model and a 'control' model. In case de-recognition criteria is met, the financial assets assigned are de-recognized and difference between carrying value and consideration including the present value of interest payments that it would not give up (excess interest spread ('EIS') receivable) is recognized as income in the Statement of Profit and Loss for the year. The assessment of derecognition criteria being met involves significant judgements and furthermore the measurement of the related EIS receivable income, servicing asset and liability requires significant estimates to be made with respect to the discount rate, expected portfolio life, prepayment and foreclosures. Given the complexity and the volume of such transactions, the same has been considered a key audit matter.	Our Audit Approach: - We have tested the design and operating effectiveness of key controls related to assignment agreements, significant estimates, judgments, including the discount rate and expected remaining life of the portfolio transferred used by the Company for computation of excess interest spread receivable. - Tested the arithmetical accuracy of computation of the excess interest spread receivable, servicing asset and servicing liability. - Assessed the disclosures made in the financial statements with respect to derecognition in accordance with the requirements of Ind AS 109 and Ind AS 107.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

The Company's Board of Directors is responsible for the matters stated in section 134(5) of the Act with respect to the preparation of these financial statements that give a true and fair view of the financial position, financial performance including other comprehensive loss, cash flows and changes in equity of the Company in accordance with the accounting principles generally accepted in India, including the Indian accounting standards (Ind AS) specified under section 133 of the Act read with the Companies (Indian Accounting Standards) Rules, 2015, as amended and directions issued by the Reserve Bank of India ("the RBI") from time to time ("RBI guidelines").

This responsibility also includes maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding of the assets of the Company and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgments and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error.

The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal financial controls relevant to the audit in order to design audit procedures that are appropriate in the circumstances. Under section 143(3)(i) of the Act, we are also responsible for expressing our opinion on whether the Company has adequate internal financial controls system in place and the operating effectiveness of such controls.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of the Board of Directors and management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Company's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Company to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the financial statements for the financial year ended March 31, 2026 and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

1. Corporate Information:

Nido Home Finance Limited ('Nido' or 'the Company') is a public limited company domiciled and incorporated on May 30, 2008 under the provisions of the Companies Act applicable in India. The Company is subsidiary of Edelweiss Rural & Corporate Services Limited. The Company is registered as Housing finance institution (without accepting public deposit) with the National Housing Bank (NHB) under section 29A of the NHB Act, 1987, registration no. is 03.0081.10.

The Company's primary business is providing loan to Retail customers for construction or purchase of residential property, loan against property and loans to real estate developers.

2. Basis of preparation:

The financial statements of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) read with section 133 of the Companies Act, 2013 (the Act) and relevant amendments, rules issued thereafter, and guidance given by RBI through its Master Directions and other relevant guidelines/circulars.

These financial statements have been prepared on a historical cost basis, except for certain financial instruments such as derivative financial instruments, other financial instruments held for trading, plan assets for defined benefit plans and share based payments which have been measured at fair value. The financial statements have been prepared on a going concern basis. The financial statements are presented in Indian Rupees (INR) and all values are rounded to the nearest million, except when otherwise indicated.

2.1 Presentation of financial statements:

The Company presents its balance sheet, Statement of Profit and Loss and statement of changes in equity in the format prescribed in the Division III of the schedule III of the Act applicable for preparation and presentation of the financial statements. The statement of cashflows has been prepared and presented as per the requirements of Ind AS 7 'Statement of Cash Flows'. The Company presents its balance sheet in order of liquidity. An analysis regarding expected recovery or settlement within 12 months after the reporting date (current) and more than 12 months after the reporting date (non-current) is presented in "Note 41-Maturity Analysis of assets and liabilities".

Financial assets and financial liabilities are generally reported gross in the balance sheet. They are only offset and reported net when, in addition to having an unconditional legally enforceable right to offset the recognised amounts without being contingent on a future event, the parties also intend to settle on a net basis in all of the following circumstances:

- The normal course of business
- The event of default
- The event of insolvency or bankruptcy of the Company and or its counterparties

2.2 Functional and Presentation Currency

The financial statements are presented in Indian Rupees which is the functional and the presentation currency of the Company and all values are rounded to the nearest Million, except when otherwise indicated.

3. Material accounting policies

3.1 Recognition of Income and Expenses

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Company and the revenue can be reliably measured and there exists reasonable certainty of its recovery.



3.1.1 Effective Interest Rate (EIR):

Under Ind AS 109 interest income is recorded using the effective interest rate (EIR) method for all financial instruments measured at amortised cost. The EIR is the rate that exactly discounts estimated future cash flows through the expected life of the financial instrument or, when appropriate a shorter period to the gross carrying amount of financial instrument.

The EIR is calculated by taking into account any discount or premium on acquisition, fees and costs that are an integral part of the EIR. The Company recognises interest income using a rate of return that represents the best estimate of a constant rate of return over the expected life of the loan. Hence, it recognises the effect of potentially different interest rates charged at various stages, and other characteristics of the product life cycle including prepayments penalty interest and charges.

If expectations regarding the cash flows on the financial asset are revised for reasons other than credit risk, the adjustment is booked as a positive or negative adjustment to the carrying amount of the asset in the balance sheet with an increase or reduction in interest income.

3.1.2 Interest Income:

The company calculates interest income by applying the EIR to the gross carrying amount of financial assets other than credit-impaired assets.

When a financial asset becomes credit-impaired and is, therefore, regarded as 'Stage 3', the Company calculates interest income by applying the EIR to the amortised cost (net of expected credit loss) of the financial asset. If the financial assets cure and is no longer credit-impaired, the Company reverts to calculating interest income on a gross basis.

Penal interest income on delayed EMI or pre EMI is recognised on receipt basis.

Interest on bank deposits are recognised on a time proportionate basis.

3.1.3 Income from Direct assignment and Co-lending:

Gains arising out of direct assignment transactions comprise the difference between the interest on the loan portfolio and the applicable rate at which the direct assignment is entered into with the assignee, also known as the right of Excess Interest Spread (EIS). The future EIS based on the expected cash flows on the execution of the transaction, discounted at the applicable rate entered into with the assignee is recorded upfront in the Statement of Profit and Loss. The EIS is reassessed at each reporting date and any subsequent increase or decrease in the fair value of future EIS is recognised in the Statement of Profit and Loss.

3.1.4 Fee and Commission Income

Fee and commission income include fees other than those that are an integral part of EIR. The Company recognises the fee and commission income in accordance with the terms of the relevant contracts / agreements and basis the probability of consideration collection. Transactional charges in the nature of bounce charges, penal charges and foreclosure charges are recognised on realisation basis.

3.1.5 Dividend Income

Dividend income is recognised when the Company's right to receive dividend is established on the reporting date.

3.1.6 Other Income

Other Income represents income earned from activities incidental to the business and is recognised when the right to receive income is established as per the terms of the contract. Other ancillary charges are recognized on realisation.



3.1.7 Borrowing Cost:

Borrowing costs include interest expense calculated using the EIR on respective financial liabilities subsequently measured at amortised cost and finance charges in respect of assets acquired on finance lease.

3.2 Financial Instruments:

3.2.1 Date of recognition:

Financial assets and liabilities except for loans and borrowings are initially recognised on the trade date, i.e. the date when Company becomes a party to the contractual provisions of the instrument. This includes regular way trades: purchases or sales of financial assets that require delivery of assets within the time frame generally established by regulation or convention in the market place. Loans are recognised when the fund transfer is initiated or disbursement cheque is handed over to the customer. The Company recognises borrowings when funds are available for utilisation to the Company.

3.2.2 Initial measurement of financial instruments:

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in profit or loss.

3.2.3 Classification and Measurement categories of financial assets and liabilities:

The Company classifies all of its financial assets based on the business model for managing the assets and the asset's contractual terms, measured at either:

- Amortised cost
- Fair value through other comprehensive income [FVOCI]
- Fair value through profit or loss [FVTPL]

The Company measures debt financial assets at amortised cost basis the following conditions:

- the financial asset is held within a business model whose objective is to hold financial assets in order to collect contractual cash flows; and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Debt instruments that meet the following conditions are subsequently measured at fair value through other comprehensive income (except for debt instruments that are designated as at fair value through profit or loss on initial recognition):

- the financial asset is held within a business model whose objective is achieved both by collecting contractual cash flows and selling the financial assets; and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

By default, all other financial assets are subsequently measured at FVTPL.



Financial assets carried at amortised cost (AC)

A financial asset is measured at amortised cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. The changes in carrying value of financial assets is recognised in Statement of Profit and Loss account.

Financial assets at fair value through other comprehensive income (FVTOCI)

A financial asset is measured at FVTOCI if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding. The changes in fair value of financial assets is recognised in Other Comprehensive Income.

Financial assets at fair value through profit or loss (FVTPL)

A financial asset which is not classified in any of the above categories are measured at FVTPL. The Company measures all financial assets classified as FVTPL at fair value at each reporting date. The changes in fair value of financial assets is recognised in the Statement of Profit and Loss.

3.3 Financial Assets and Liabilities:

3.3.1 Financial assets held for trading:

The Company classifies financial assets as held for trading when they have been purchased primarily for short-term profit making through trading activities or form part of a portfolio of financial instruments that are managed together, for which evidence of a recent pattern of short-term profit is taking. Held-for-trading assets are recorded and measured in the balance sheet at fair value. Changes in fair value are recognised in net gain on fair value changes.

3.3.2 Debt securities and other borrowed funds:

The Company measures debt issued and other borrowed funds at Amortised cost at each reporting date. Amortised cost is calculated by taking into account any discount or premium on issue funds, and costs that are an integral part of the EIR.

3.3.3 Financial liabilities:

All financial liabilities are measured at amortised cost.

3.3.4 Loan Commitments:

Undrawn loan commitments are commitments under which, the Company is required to provide a loan with pre-specified terms to the customer over the duration of the commitment. Un-Cancellable loan commitments are in the scope of the ECL requirements.

3.4 Reclassification of Financial assets and liabilities

The Company does not reclassify its financial assets subsequent to their initial recognition, apart from the exceptional circumstances in which the Company acquires, disposes of, or terminates a business line. The Company has not reclassified any of its financial assets or liabilities in current year and previous year.



3.5 Derecognition of financial Instruments:

3.5.1 Derecognition of financial asset

A financial asset (or, where applicable a part of a financial asset or a part of a group of similar financial assets) is derecognised when the rights to receive contractual cash flows from the financial asset have expired. The Company also derecognises the financial asset if it has both transferred the financial asset and the transfer qualifies for derecognition.

The Company has transferred the financial asset if, and only if, either

- The Company has transferred the rights to receive cash flows from the financial asset or
- It retains the contractual rights to receive the cash flows of the financial asset, but assumed a contractual obligation to pay the cash flows in full without material delay to third party under pass through arrangement.

Pass-through arrangements are transactions whereby the Company retains the contractual rights to receive the cash flows of a financial asset (the 'original asset'), but assumes a contractual obligation to pay those cash flows to one or more entities (the 'eventual recipients'), when all of the following conditions are met:

- The Company has no obligation to pay amounts to the eventual recipients unless it has collected equivalent amounts from the original asset, excluding short-term advances with the right to full recovery of the amount lent plus accrued interest at market rates.
- The Company cannot sell or pledge the original asset other than as security to the eventual recipients.

The Company has to remit any cash flows it collects on behalf of the eventual recipients without material delay. In addition, the Company is not entitled to reinvest such cash flows, except for investments in cash or cash equivalents including interest earned, during the period between the collection date and the date of required remittance to the eventual recipients.

A transfer only qualifies for derecognition if either:

- The Company has transferred substantially all the risks and rewards of the asset; or
- The Company has neither transferred nor retained substantially all the risks and rewards of the asset but has transferred control of the asset.

The Company considers control to be transferred if and only if, the transferee has the practical ability to sell the asset in its entirety to an unrelated third party and is able to exercise that ability unilaterally and without imposing additional restrictions on the transfer.

The Company also derecognises a financial asset, when the terms and conditions have been renegotiated to the extent that, substantially, it becomes a new financial asset, with the difference recognised as a derecognition gain or loss, to the extent that an impairment loss has not already been recorded.

If the modification does not result in cash flows that are substantially different, the modification does not result in derecognition. Based on the change in cash flows discounted at the original EIR, the Company records a modification gain or loss, to the extent that an impairment loss has not already been recorded.

The Company, on de-recognition of financial assets under the direct assignment transactions, recognises the right of excess interest spread (EIS) which is difference between interest on the loan portfolio assigned and the applicable rate at which the direct assignment is entered into with the assignee. The Company records the discounted value of behaviour cash flow of the future EIS, entered into with the assignee, upfront in the Statement of Profit and Loss. The embedded interest component in the future EIS is recognised as interest income in line with Ind AS 109 'Financial instruments'.



3.5.2 Derecognition of financial liabilities

A financial liability is derecognised when the obligation under the liability is discharged, cancelled or expires. Where an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and the recognition of a new liability. The difference between the carrying value of the original financial liability and the consideration paid, including modified contractual cash flow recognised as new financial liability, is recognised in the statement of profit and loss.

3.6 Impairment of financial assets:

The Company records provisions based on expected credit loss model ("ECL") on all loans, other financial assets not measured at FVTPL, undrawn loan commitments and financial guarantee contracts, in this section all referred to as "Financial instrument". Equity instruments are not subject to impairment.

ECL is a probability-weighted estimate of credit losses. A credit loss is the difference between the cash flows that are due to an entity in accordance with the contract and the cash flows that the entity expects to receive discounted at the original effective interest rate. As ECL considers the amount and timing of payments, a credit loss arises even if the entity expects to be paid in full but later than when contractually due.

Simplified Approach

The Company follows 'simplified approach' for recognition of impairment loss allowance on trade receivables. The application of simplified approach does not require the Company to track changes in credit risk. Rather, it recognises impairment loss allowance based on lifetime ECLs at each reporting date, right from its initial recognition. The Company uses a provision matrix to determine impairment loss allowance on portfolio of its receivables. The provision matrix is based on its historically observed default rates over the expected life of the receivables. However, if receivables contain a significant financing component, the Company chooses as its accounting policy to measure the loss allowance by applying general approach to measure ECL.

General Approach

For all other financial instruments, the Company recognises lifetime ECL when there has been a significant increase in credit risk (SICR) since initial recognition. If, on the other hand, the credit risk on the financial instrument has not increased significantly since initial recognition, the Company measures the loss allowance for that financial instrument at an amount equal to 12-month expected credit losses (12m ECL). The assessment of whether lifetime ECL should be recognised is based on significant increases in the likelihood or risk of a default occurring since initial recognition instead of an evidence of a financial asset being credit-impaired at the reporting date or an actual default occurring.

Lifetime ECL represents the expected credit losses that will result from all possible default events over the expected life of a financial instrument. In contrast, 12m ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

The measurement of expected credit losses is a function of the probability of default (PD), loss given default (LGD) (i.e. the magnitude of the loss if there is a default) and the exposure at default. The assessment of the probability of default and loss given default is based on historical data adjusted by forward-looking information. As for the exposure at default (EAD), for financial assets, this is represented by the assets' gross carrying amount at the reporting date; for loan commitments and financial guarantee contracts, the exposure includes the amount drawn down as at the reporting date, together with any additional amounts expected to be drawn down in the future by default date determined based on historical trend, the Company's understanding of the specific future financing needs of the debtors, and other relevant forward-looking information.



Company categorises its financial assets as follows:

Stage 1 Assets:

Stage 1 assets includes financial instruments that did not have a significant increase in credit risk since initial recognition or that have low credit risk at the reporting date. For these assets, 12-month ECL (resulting from default events possible within 12 months from reporting date) are recognised.

Stage 2 Assets:

Stage 2 Assets includes financial instruments that have a significant increase in credit risk since initial recognition. For these assets lifetime ECL (resulting from default events possible within 12 months from reporting date) are recognised.

Stage 3 Assets:

Stage 3 Assets are considered credit-impaired the Company recognises the lifetime ECL for these loans. The method is similar to that for Stage 2 assets, with the PD set at 100%.

Company recognises an impairment gain or loss in Statement of Profit and Loss for all financial instruments with a corresponding adjustment to their carrying amount through a loss allowance account.

The expected credit loss on the uncancellable loan commitment is recognised together with the loss allowance for the financial asset.

The Company's product offering includes working capital facilities with a right to Company to cancel and/or reduce the facilities with one day's notice. The Company does not limit its exposure to credit losses to the contractual notice period, but, instead calculates ECL over a period that reflects the Company's expectations of the customer behaviour, its likelihood of default and the Company's future risk mitigation procedures, which could include reducing or cancelling the facilities.



3.7 Collateral Valuation:

To mitigate its credit risks on financial assets, the Company seeks to use collateral, where possible. The collateral comes in various forms, such as cash, securities, letters of credit /guarantees, real estate, receivables, inventories, other non-financial assets and credit enhancements such as netting agreements. Collateral, unless repossessed, is not recorded on the Company's balance sheet. However, the fair value of collateral affects the calculation of ECL. It is generally assessed, at a minimum, at inception and re-assessed on a periodic basis. However, some collateral, for example, securities relating to margin requirements, is assessed on a daily basis.

To the extent possible, the Company uses active market data for valuing financial assets held as collateral. Other financial assets which do not have readily determinable market value are valued using models.

3.8 Collateral Repossessed:

The Company's policy is to determine whether a repossessed asset can be best used for its internal operations or should it be sold. Assets determined to be useful for the internal operations are transferred to their relevant asset category at the lower of their repossessed value or the carrying value of the original secured asset. Assets for which selling is determined to be a better option are transferred to assets held for sale at their fair value (if financial assets) and fair value less cost to sell for non-financial assets at the repossession date, in line with the Company's policy.

In its normal course of business, the Company does not physically repossess properties or other assets in its retail portfolio, but engages external agents to recover funds, generally at auction, to settle outstanding debt. Any surplus funds are returned to the customers/obligors. As a result of this practice, the residential properties under legal repossession processes are not recorded on the balance sheet.

3.9 Write-Offs:

Financial assets are written off either partially or in their entirety only when the Company has no reasonable expectation of recovery besides technical write off as per relevant policy.

3.10 Forborne and modified loan:

The Company sometimes makes concessions or modifications to the original terms of loans as a response to the borrower's financial difficulties, rather than taking possession or to otherwise enforce collection of collateral. The Company considers a loan forborne when such concessions or modifications are provided as a result of the borrower's present or expected financial difficulties and the Company would not have agreed to them if the borrower had been financially healthy. Indicators of financial difficulties include defaults on covenants, or significant concerns raised by the Credit Risk Department. Forbearance may involve extending the payment arrangements and the agreement of new loan conditions. Once the terms have been renegotiated, any impairment is measured using the original EIR as calculated before the modification of terms. It is the Company's policy to monitor forborne loans to help ensure that future payments continue to be likely to occur. Derecognition decisions and classification between Stage 2 and Stage 3 are determined on a case-by-case basis. If these procedures identify a loss in relation to a loan, it is disclosed and managed as an impaired Stage 3 forborne asset, until it is collected or written off.

3.11 Determination of Fair Value:

The Company measures financial instruments, such as, derivatives at fair value at each reporting date. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place either;

- In the principal market for the asset or liability, or
- In the absence of a principal market, in the most advantageous market for the asset or liability.

The principal or the most advantageous market must be accessible by the Company.



The fair value of an asset or a liability is measured using the assumptions that market participants would use when pricing the asset or liability, assuming that market participants act in their economic best interest. A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use or by selling it to another market participant that would use the asset in its highest and best use. The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs. In order to show how fair values have been derived, financial instruments are classified based on a hierarchy of valuation techniques, as summarised below:

Level 1 Financial Instruments:

Those where the inputs used in the valuation are unadjusted quoted prices from active markets for identical assets or liabilities that the Company has access to at the measurement date. The Company considers markets as active only if there are sufficient trading activities with regards to the volume and liquidity of the identical assets or liabilities and when there are binding and exercisable price quotes available on the balance sheet date.

Level 2 Financial Instruments:

Those where the inputs that are used for valuation and are significant, are derived from directly or indirectly observable market data available over the entire period of the instrument's life.

Level 3 Financial Instruments:

Those that include one or more unobservable input that is significant to the measurement as whole. For assets and liabilities that are recognised in the financial statements on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorization (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period. The Company periodically reviews its valuation techniques including the adopted methodologies and model calibrations.

Therefore, the Company applies various techniques to estimate the credit risk associated with its financial instruments measured at fair value, which include a portfolio-based approach that estimates the expected net exposure per counterparty over the full lifetime of the individual assets, in order to reflect the credit risk of the individual counterparties for non-collateralised financial instruments.

The Company evaluates the levelling at each reporting period on an instrument-by-instrument basis and reclassifies instruments when necessary based on the facts at the end of the reporting period.

3.12 Leases:

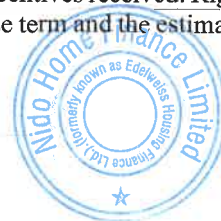
Company as a lessee:

The Company has applied Ind AS 116 using the partial retrospective approach.

The Company assesses at contract inception whether a contract is, or contains, a lease. That is, if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. The Company applies a single recognition and measurement approach for all leases, except for short-term leases and leases of low-value assets. The Company recognises lease liabilities to make lease payments and right-of-use assets representing the right to use the underlying assets.

Right of Use Assets

The Company recognises right-of-use assets at the commencement date of the lease (i.e., the date the underlying asset is available for use). Right-of-use assets are measured at cost, less any accumulated depreciation and impairment losses, and adjusted for any remeasurement of lease liabilities. The cost of right-of-use assets includes the amount of lease liabilities recognised, initial direct costs incurred, and lease payments made at or before the commencement date less any lease incentives received. Right-of-use assets are depreciated on a straight-line basis over the shorter of the lease term and the estimated useful lives of the assets.



Lease liabilities

At the commencement date of the lease, the Company recognises lease liabilities measured at the present value of lease payments to be made over the lease term. The lease payments include fixed payments (including in substance fixed payments) less any lease incentives receivable, variable lease payments that depend on an index or a rate, and amounts expected to be paid under residual value guarantees. In calculating the present value of lease payments, the Company uses its incremental borrowing rate at the lease commencement date because the interest rate implicit in the lease is not readily determinable. After the commencement date, the amount of lease liabilities is increased to reflect the accretion of interest and reduced for the lease payments made. In addition, the carrying amount of lease liabilities is remeasured if there is a modification, a change in the lease term, a change in the lease payments (e.g., changes to future payments resulting from a change in an index or rate used to determine such lease payments) or a change in the assessment of an option to purchase the underlying asset.

Short term lease

The Company has elected not to recognise right of use assets and lease liabilities for short term leases of property that has lease term of 12 months or less. The Company recognises lease payment associated with these leases as an expense on a straight line basis over lease term.

Company as lessor:

The Company's accounting policy under Ind AS 116 has not changed from the comparative period. As a lessor the Company classifies its leases as either operating or finance leases. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset and classified as an operating lease if it does not.

3.13 Earnings Per Share:

Basic earnings per share is computed by dividing the net profit after tax attributable to the equity shareholders for the year by the weighted average number of equity shares outstanding for the year.

Diluted earnings per share reflect the potential dilution that could occur if securities or other contracts to issue equity shares were exercised or converted during the year. Diluted earnings per share is computed by dividing the net profit after tax attributable to the equity shareholders for the year by weighted average number of equity shares considered for deriving basic earnings per share and weighted average number of equity shares that could have been issued upon conversion of all potential equity shares.

3.14 Retirement and other employee benefits:

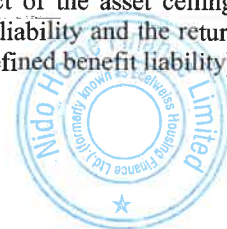
3.14.1 Provident fund and National Pension Scheme:

The Company contributes to a recognised provident fund and national pension scheme which is a defined contribution scheme. The contributions are accounted for on an accrual basis and recognised in the Statement of Profit and Loss.

3.14.2 Gratuity:

The Company's gratuity scheme is a defined benefit plan. The Company's net obligation in respect of the gratuity benefit scheme is calculated by estimating the amount of future benefit that the employees have earned in return for their service in the current and prior periods, that benefit is discounted to determine its present value, and the fair value of any plan assets, if any, is deducted. The present value of the obligation under such benefit plan is determined based on independent actuarial valuation using the Projected Unit Credit Method.

Re-measurement, comprising of actuarial gains and losses, the effect of the asset ceiling, excluding amounts included in net interest on the net defined benefit liability and the return on plan assets (excluding amounts included in net interest on the net defined benefit liability),



are recognised immediately in the balance sheet with a corresponding debit or credit to retained earnings through OCI in the period in which they occur.

Remeasurement are not reclassified to Statement of Profit and Loss in subsequent periods.

3.14.3 Compensated Absences:

The eligible employees of the Company are permitted to carry forward certain number of their annual leave entitlement to subsequent years, subject to a ceiling. The Company recognises the charge in the Statement of Profit and Loss and corresponding liability on such non-vesting accumulated leave entitlement based on a valuation by an independent actuary. The cost of providing annual leave benefits is determined using the projected unit credit method.

3.14.4 Equity-settled share-based payments:

ESOP given by ultimate parent Company:

Equity-settled share-based payments to employees are granted by the ultimate parent Company. These are measured by reference to the fair value of the equity instruments at the grant date. These includes Stock Appreciation Rights (SARs) where the right to receive the difference between the SAR price and the market price of equity shares of the ultimate parent Company on the date of exercise, either by way of cash or issuance of equity shares of the ultimate parent Company, is at the discretion of the ultimate parent Company. These are classified as equity settled share based transaction.

The fair value determined at the grant date of the equity-settled share-based payments is expensed over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity. At the end of each reporting period, the Group revises its estimate of the number of equity instruments expected to vest. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the 'ESOP reserve'. In cases where the share options granted vest in instalments over the vesting period, the Group treats each instalment as a separate grant, because each instalment has a different vesting period, and hence the fair value of each instalment differs.

ESOP given by the Company:

Equity-settled share-based payments to employees that are granted by the Company are measured by reference to the fair value of the equity instruments at the grant date. In order to arrive at the fair value of the options, the Black-Scholes Option Pricing formula is used.

The fair value determined at the grant date of the equity-settled share-based payments is expensed over the vesting period, based on the Company's estimate of equity instruments that will eventually vest, with a corresponding increase in equity. At the end of each reporting period, the Company revises its estimate of the number of equity instruments expected to vest. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to the Employee Stock Option Reserve. In cases where the share options granted vest in tranche over the vesting period, the Company treats each tranche as a separate grant, because each tranche has a different vesting period, and hence the fair value of each tranche differs.

3.15 Property, Plant and Equipment (PPE):

Property plant and equipment is stated at cost excluding the costs of day-to-day servicing, less accumulated depreciation and accumulated impairment in value. PPE is recognised when it is probable that future economic benefits associated with the item is expected to flow to the Company and the cost of the item can be measured reliably. Changes in the expected useful life are accounted for by changing the amortisation period or methodology, as appropriate, and treated as changes in accounting estimates.

Subsequent costs incurred on an item of property, plant and equipment is recognised in the carrying amount thereof when those costs meet the recognition criteria as mentioned above. Repairs and maintenance are recognised in Statement of Profit and Loss as incurred.



Depreciation is recognised so as to write off the cost of assets (other than freehold land and properties under construction) less their residual values over their useful lives. Depreciation is provided on a written down value basis from the date the asset is ready for its intended use or put to use whichever is earlier. In respect of assets sold, depreciation is provided upto the date of disposal.

As per the requirement of Schedule II of the Companies Act, 2013, the Company has evaluated the useful lives of the respective Property, Plant and Equipments which are as per the provisions of Part C of the Schedule II for calculating the depreciation. The estimated useful lives of the Property, Plant and Equipments are as follows:

Nature of assets	Estimated useful lives
Furniture and fixtures	10 years
Vehicles	8 years
Office Equipment	5 years
Computers - Servers and networks	6 years
Computers - End user devices, such as desktops, laptops, etc.	3 years

Leasehold improvements are amortised on a straight-line basis over the estimated useful lives of the assets or the period of lease whichever is earlier.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The carrying amount of those components which have been separately recognised as assets is derecognised at the time of replacement thereof. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the asset and is recognised in the Statement of profit or loss.

The residual values, useful lives and methods of depreciation of property, plant and equipment are reviewed at each financial year end and adjusted prospectively, if appropriate.

3.16 Intangible Assets:

Intangible assets are recorded at the consideration paid for the acquisition of such assets and are carried at cost less accumulated amortization and impairment, if any. Intangibles such as software are amortised over a period of 3 to 5 years based on its estimated useful life.

Intangible assets not ready for intended use as on the balance sheet date are disclosed as Intangible Asset Under Development.

3.17 Impairment of non-financial assets:

The Company assesses at each balance sheet date whether there is any indication that an asset may be impaired based on internal/external factors. If any such indication exists, the Company estimates the recoverable amount of the asset. If such recoverable amount of the asset or the recoverable amount of cash generating unit which the asset belongs to is less than its carrying amount, the carrying amount is reduced to its recoverable amount. The reduction is treated as an impairment loss and is recognized in the Statement of Profit and Loss. If at the balance sheet date there is an indication that a previously assessed impairment loss no longer exists, the recoverable amount is reassessed and the assets is reflected at the recoverable amount subject to a maximum of the depreciable historical cost.

3.18 Provisions, contingent liabilities and contingent assets:

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that the Company will be required to settle the obligation, and a reliable estimate can be made of the amount of the obligation. If the effect of the time value of money is material, provisions are determined by discounting the expected future cash flows to net present value using an appropriate pre-tax discount rate that reflects current market assessments of the time value of money and, where appropriate, the risks specific to the liability.



A present obligation that arises from past events, where it is either not probable that an outflow of resources will be required to settle or a reliable estimate of the amount cannot be made, is disclosed as a contingent liability. Contingent liabilities are also disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company. Claims against the Company, where the possibility of any outflow of resources in settlement is remote, are not disclosed as contingent liabilities.

Contingent assets are not recognised in the financial statements since this may result in the recognition of income that may never be realised. However, when the realisation of income is virtually certain, then the related asset is not a contingent asset and is recognised.

3.19 Cash and cash equivalents

Cash and cash equivalents in the balance sheet comprise of cash at banks and in hand, short-term deposits with an original maturity of three months or less and highly liquid investments that are readily convertible into cash and which are subject to an insignificant risk of change in value.

3.20 Income tax expenses:

Income tax expense represents the sum of the tax currently payable and deferred tax.

3.20.1 Current tax:

The tax currently payable is based on taxable profit for the year. Taxable profit differs from 'profit before tax' as reported in the Statement of Profit and Loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible. The Company's current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

3.20.2 Deferred tax:

Deferred tax is recognised on temporary differences arising between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Company expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.



3.20.3 Current and Deferred tax for the year:

Current and deferred tax are recognised in profit or loss, except when they relate to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

3.21 Investment Properties;

Properties, including those under construction, held to earn rentals and/or capital appreciation are classified as investment property and are measured and reported at cost, including transaction costs. Depreciation is recognised using straight line method so as to write off the cost of the investment property less their residual values over their useful lives specified in Schedule II to the Companies Act, 2013 or in the case of assets where the useful life was determined by technical evaluation, over the useful life so determined. Depreciation method is reviewed at each financial year end to reflect the expected pattern of consumption of the future benefits embodied in the investment property.

The estimated useful life and residual values are also reviewed at each financial year end and the effect of any change in the estimates of useful life/residual value is accounted on prospective basis.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from the disposal. Any gain or loss arising on derecognition of property is recognised in the Statement of Profit and Loss in the same period.

3.22 Exceptional items:

An item of income or expense which its size, type or incidence requires disclosure in order to improve an understanding of the performance of the Company is treated as an exceptional item and the same is disclosed in the notes to accounts.

4. Significant accounting judgements, estimates and assumptions:

The preparation of these financial statements in conformity with Ind AS requires the management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amount of assets, liabilities, income and expenses. Actual results may differ from those estimates.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected. In particular, information about significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements are included are given below:

4.1 Business model assessment:

The Company determines the business model at a level that reflects how the financial assets are managed together to achieve a particular business objective. This assessment includes judgement reflecting all relevant evidence including how the performance of the assets is evaluated and their performance measured, the risks that affect the performance of the assets and how these are managed and how the managers of the assets are compensated. The Company monitors financial assets measured at amortised cost that are derecognised prior to their maturity to understand the reason for their disposal and whether the reasons are consistent with the objective of the business for which the asset was held. Monitoring is part of the Company's continuous assessment of whether the business model for which the remaining financial assets are held continues to be appropriate and if it is not appropriate whether there has been a change in business model and so a prospective change to the classification of those instruments.

4.2 Significant increase in credit risk:

As explained in note 4.1, ECL is measured as an allowance equal to 12-month ECL for stage 1 assets, or lifetime ECL for stage 2 or stage 3 assets. An asset moves to stage 2 when its credit risk has increased



significantly since initial recognition. Ind AS 109 does not define what constitutes a significant increase in credit risk. In assessing whether the credit risk of an asset has significantly increased the Company takes into account qualitative and quantitative reasonable and supportable forward-looking information. Refer to note 46.1 for more details.

4.3 Key sources of estimation uncertainty:

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period that may have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year, as described below. The Company based its assumptions and estimates on parameters available when the financial statements were prepared. Existing circumstances and assumptions about future developments, however, may change due to market changes or circumstances arising that are beyond the control of the Company. Such changes are reflected in the assumptions when they occur.

4.4 Fair value of financial instruments:

~~The Fair value of financial instruments that are not traded in an active market is determined using~~ valuation techniques. The Company uses its judgement to select a variety of methods and make assumptions based on market conditions existing at the end of each reporting period. Judgements and estimates include considerations of liquidity and model inputs related to items such as credit risk, funding value adjustments, correlation and volatility.

4.5 Effective Interest Rate (EIR) Method:

The Company's EIR methodology, as explained in Note 3.1.1, recognises interest income / expense using a rate of return that represents the best estimate of a constant rate of return over the expected behavioural life of loans given / taken and recognises the effect of potentially different interest rates at various stages and other characteristics of the product life cycle including prepayments and penalty interest and charges.

This estimation, by nature requires an element of judgement regarding the expected behaviour and life cycle of the instrument, as well expected changes India's base rate and other fee income, expenses that are integral part of the instrument

4.6 Impairment of Financial assets:

The impairment provisions for the financial assets except assets valued at fair value through Profit & Loss account (FVTPL) are based on assumptions about estimation of the amount and timing of future cash flows, collateral values, assessment of a significant increase in credit risk, probability of default (PD) and Loss given default (LGD) rates. The Company uses judgements in making these assumptions and selecting the inputs for impairment calculations based on its past history, existing market conditions and forward looking estimates at the end of each period. These estimates are driven by number of factors, change in which can result in different level of allowance.

The Company's expected credit loss (ECL) calculations are output of complex model with number of underlying assumptions regarding choice of variable inputs and their interdependencies Elements of the ECL models that are considered accounting judgements and estimates include:

- The Company's internal credit grading model, which assigns PDs to the individual grades based on ageing.
- The Company's criteria for assessing if there has been a significant increase in credit risk and so allowances for financial assets should be measured on a life time ECL basis and the qualitative assessment.
- The segmentation of financial assets when their ECL is assessed on a collective basis.



- Development of ECL models, including the various formulas and the choice of inputs
Determination of associations between macroeconomic scenarios and, economic inputs, such as unemployment levels and collateral values, and the effect on PDs, EADs and LGDs.
- Selection of forward-looking macroeconomic scenarios and their probability weightings, to derive the economic inputs into the ECL models.

It has been the Company's policy to regularly review its models in the context of actual loss experience and adjust when necessary.

4.7 Accounting for deferred taxes:

Deferred tax assets are recognised for unused tax losses to the extent that it is probable that taxable profit will be available against which the losses can be utilised. Significant management judgement is required to determine the amount of deferred tax assets that can be recognised, based upon the likely timing and the level of future taxable profits together with future tax planning strategies.

4.8 Share-based payments:

Estimating fair value for share-based payment transactions requires determination of the most appropriate valuation model, which is dependent on the terms and conditions of the grant. This estimate also requires determination of the most appropriate inputs to the valuation model including the expected life of the share option, volatility and dividend yield and making assumptions about them.

5. Recent pronouncements:

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time.

In May 2025, MCA notified amendments to Ind AS 21 - The Effects of Changes in Foreign Exchange Rates, applicable w.e.f. April 1, 2025. The Company has reviewed the amendment and based on its evaluation has determined that it does not have any significant impact in its financial statements.

In August 2025, MCA notified the following amendments to:

1. Ind AS 1, Presentation of Financial Statements, applicable w.e.f. April 1, 2025 – The amendment relates to classification of liabilities as current or non-current and non-current liabilities with covenants. In the context of classifying a liability as current, it removes the requirement of existence of a right to defer settlement for at least 12 months after the reporting date and instead requires that the said right should exist on the reporting date and have substance. The amendment also introduces guidance on classification of liabilities with covenants. The Company has no impact of these amendments in its classification criteria of current and non-current liabilities.

2. Ind AS 7, Statement of Cash Flows and Ind AS 107, Financial Instruments: Disclosures, applicable w.e.f. April 1, 2025 – The amendment in Ind AS 7 requires to inform users of financial statements of the existence of supplier finance arrangements and explain the nature of the arrangements, the carrying amount of liabilities and the range of payment due dates. Ind AS 107 has been amended to add supplier finance arrangements as a factor that may cause concentration of liquidity risk. The Company has reviewed the amendment and based on its evaluation has determined that it does not have any significant impact in its financial statements.

3. Ind AS 12, International Tax Reform – Pillar Two Model Rules applicable immediately - The amendments provide a temporary mandatory relief from deferred tax accounting for top-up tax and require companies to disclose that they have applied the relief. This relief is immediate and applies retrospectively. The amendments also require companies to provide new disclosures to compensate for potential loss of information resulting from the relief. Such disclosures are to be provided for annual reporting periods beginning on or after April 1, 2025. The Company has reviewed the amendment and based on its evaluation has determined that it does not have any significant impact in its financial statements.

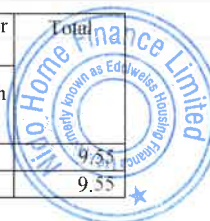

27.1 Nature and purpose of Reserves**(a) Securities Premium**

Securities premium is used to record the premium on issue of shares. Balance in Securities premium can be utilised only for limited purposes such as issuance of bonus shares in accordance with the provisions of the Companies Act, 2013.

(b) Statutory reserve under section 29C of the National Housing Bank Act, 1987

Reserve created under section 29C of National Housing Bank Act, 1987 a sum not less than twenty per cent of its net profit every year as disclosed in the Statement of Profit and Loss and before any dividend is declared.

(c) Debenture Redemption Reserve

The Companies Act 2013 requires companies that issue debentures to create a debenture redemption reserve from annual profits until such debentures are redeemed. Company being Housing Finance Company (HFC) has to maintain Debenture Redemption reserve upto 25% of the value of debentures issued through public issue. The amounts credited to the debenture redemption reserve may not be utilised except to redeem debentures. On redemption of debentures, the amount may be transferred from debenture redemption reserve to retained earnings. However, as per the amendment in the Companies Act 2013, debenture redemption reserve is not required for debentures issued by Non-Banking Finance Companies (including HFC) regulated by Reserve Bank of India for both public as well as privately placed debentures.

This reserve relates to Share options granted to eligible employees of the Company by the parent company under its employee share option plan.

(e) Retained Earnings

It represents surplus earned by the Company till date after appropriations/ transfers and cumulative actuarial gains/(losses) on defined employee benefit plans.

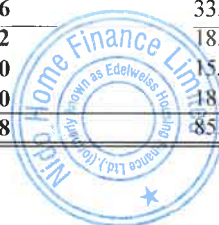

i. The Company's pending litigations mainly comprise of claims against the Company pertaining to proceedings pending with Income Tax and other authorities. The Income Tax Department ("the Department") conducted a Search under Section 132 of the Income Tax Act ('IT Act') ("the Search") on the Edelweiss Group during March 2023 and has subsequently raised a demand order for the AY 2019-20 to AY 2023-24. The company has filed appeal/s and is defending its position. Based on the favourable outcome in Appellate proceedings in the past and as advised by the tax advisors, company is reasonably certain about sustaining its position in the pending cases, hence the possibility of outflow of resources embodying economic benefits on this ground is remote. While the uncertainty exists regarding the outcomes of the legal proceedings, the management of the Company has evaluated the demand orders after considering all available records and facts known to it and based on an independent legal review and opinion from external legal counsels and believes that the Company can succeed in the appeals filed against the aforesaid demand orders and accordingly no adjustments to the current or prior period required in financial statements.

In accordance with Employees' Provident Fund and Miscellaneous Provisions Act, 1952, employees of the Company are entitled to receive benefits under the provident fund, a defined contribution plan, in which, both the employee and the Company contribute monthly at a determined rate. These contributions are made to a recognized provident fund administered by Regional Provident Fund Commissioner. The employees contribute 12% of their basic salary and the Company contributes an equal amount.

The Company recognised Rs.40.97 million (Previous year Rs Rs.40.25 million) for provident fund in the Statement of profit and loss.

(b) Defined benefit plan - Gratuity

The Government of India, vide notification dated November 21, 2025, has notified the new Labour Code, that has reassessed employee benefit obligations on the revised definition of wages and expanded eligibility criteria. The gratuity benefit is provided through unfunded plan and annual expense is charged to the statement of profit and loss on the basis of actuarial valuation.

The most recent actuarial valuation of plan assets and the present value of the defined benefit obligation (DBO) for gratuity are carried out as at March 31, 2026. The present value of the defined benefit obligations and the related current service cost and past service cost, are measured using the Projected Unit Credit Method.

(c) The Government of India, vide notification dated November 21, 2025, has notified the new Labour Code, basis which the Company has reassessed its employee benefit obligations based on the revised definition of wages and expanded eligibility criteria. Accordingly, based on actuarial valuation and management estimates, the Company has recognized an incremental expense of Rs. 22.98 million during the year ended March 31, 2026 on account of past service cost in accordance with Ind AS 19 – Employee Benefits and disclosed as an exceptional item. 45 Cost sharing

Edelweiss Financial Services Limited, being the ultimate holding company along with fellow subsidiaries incurs expenditure like, Group Medclaim, insurance, rent, electricity charges etc. which is for the common benefit of itself and its certain subsidiaries, fellow subsidiaries including the Company. This cost so expended is reimbursed by the Company on the basis of number of employees, time spent by employees of other Companies, actual identifications etc. On the same lines, employees' costs expended (if any) by the company for the benefit of fellow subsidiaries is recovered by the Company. Accordingly, and as identified by the management, the expenditure heads in note 34 and 35 include reimbursements paid and are net of reimbursements received (Refer note 43).



46. Risk Management

(a) Introduction and risk profile

Risk is an inherent part of Company's business activities. When the Company extends a corporate or retail loan, buys or sells securities in market, or offers other products and services, it takes on some degree of risk. The Company's overall objective is to manage its business and associated risks in a manner that balances serving the interests of its customers and investors and protects while protecting the safety and soundness of the Company.

The Company believes that effective risk management requires:

- 1) Acceptance of responsibility, including identification and escalation of risk issues, by all individuals within the Company;
- 2) Ownership of risk identification, assessment, data and management within each of the lines of business; and
- 3) Firmwide structures for risk governance.

The Company strives for continual improvement through efforts to enhance controls, ongoing employee training and development, and other measures.

(b) Risk Management Structure

The Company have a well-defined risk management framework for risk identification, assessment and control to effectively manage risks associated with its various business activities.

The Company's risk management policy ensures that the margin requirements are conservative to withstand market volatility and scenarios of sharply declining prices. As a result, the Company follows conservative lending norms. The Company centralises its risk monitoring systems to monitor its client's credit exposure, which is in addition to the monitoring undertaken by the respective businesses.

The Company's Board of Directors has overall responsibility for the establishment and oversight of the Company's risk management framework. The Board has established the Risk Management Committee, which is responsible for developing and monitoring the Company's risk management policies. The Committee holds regular meetings and report to Board on its activities.

The Audit Committee oversees how management monitors compliance with the Company's risk management policies and procedures and reviews the adequacy of the risk management framework in relation to the risks faced by the Company. The Audit Committee is assisted in its oversight role by Internal Audit. Internal Audit provides independent assurance to the Audit Committee that key risks are effectively managed, and controls are functioning as intended.

(c) Risk Mitigation and Risk Culture

The Company's business processes ensure complete independence of functions and a segregation of responsibilities. Credit appraisal and credit control processes, a centralised operations unit, an independent audit unit for checking compliance with the prescribed policies and approving loans at the transaction level, as well as the Company's risk management processes and policies, allow for multiple layers of checks and verifications. The Company's key business processes are regularly monitored by the business and/or operation heads. The Company's loan approval and administration procedures, collection and enforcement procedures are designed to minimise delinquencies and maximise recoveries.

It is the Company's policy that a quarterly briefing is given to the Board of Directors and all other relevant stakeholder on the utilisation of market limits, proprietary investments and liquidity, along with any other risk developments.

It is the Company's policy to ensure that a robust risk awareness is embedded in its organisational risk culture. Employees are expected to take ownership of and be accountable for the risks the Company is exposed to and that they decide to take on. The Company's continuous training and development programme ensures that employees are made aware of the Company's risk appetite and are supported in their roles and responsibilities to monitor and keep their exposure to risk within its risk appetite limits. Compliance breaches and internal audit findings are important elements of employees' annual ratings and remuneration reviews.

46.1. Credit Risk

Credit risk is the risk of financial loss to the Company if a customer or counterparty to a financial instrument fails to meet its contractual obligations, and arises principally from the Company's loans and trade receivables. The Company has a policy of dealing with creditworthy counterparties and obtains sufficient collateral, where appropriate, as a means of mitigating the risk of financial loss from defaults. In case the loans are to be restructured, similar credit assessment process is followed by the Company.

The Company's exposure to credit risk is influenced mainly by the individual characteristics of each customer. However, management also considers the factors that may influence the credit risk of its customer base, including the default risk of the industry and country in which customers operate.

The Company manages and controls credit risk by setting limits on the amount of risk it is willing to accept for individual counterparties/Groups (Single Borrowing Limit/Group Borrowing Limit) and for industry concentrations, and by monitoring exposures in relation to such limits.

Credit quality of a customer is assessed based on its credit worthiness and historical dealings with the Company and market intelligence. Outstanding customer-receivables are regularly monitored. The credit quality review process aims to allow the Company to assess the potential loss as a result of the risks to which it is exposed and take corrective actions.

(a) Impairment Assessment:

The Company applies the expected credit loss model for recognising impairment loss. The expected credit loss allowance is computed based on a provision matrix which takes into account historical credit loss experience and adjusted for forward-looking information.

The expected credit loss is a product of exposure at default, probability of default and loss given default. The Company has devised an internal model to evaluate the probability of default and loss given default based on the parameters set out in Ind AS. Accordingly, the loans are classified into various stages as follows:

(b) Expected Credit Loss

Credit loss is the difference between all contractual cash flows that are due to an entity in accordance with the contract and all the cash flows that the entity expects to receive (i.e., all cash shortfalls), discounted at the original EIR. Expected Credit Loss (ECL) computation is not driven by any single methodology, however methodology and approach used must reflect the following:

- An unbiased and probability weighted amount that evaluates a range of possible outcomes
- Reasonable and supportable information that is available without undue cost and effort at the reporting date about past events, current conditions and forecasts of future economic conditions;
- Time value of money

While the time value of money element is currently being factored into ECL measurement while discounting cash flows by the Effective Interest Rate (EIR), the objective of developing a macroeconomic model using exogenous macroeconomic variables (MEVs) is to address the first two requirements. This has been achieved by using the model output to adjust the PD risk component in order to make it forward looking and probability-weighted.

(c) Significant increase in credit risk (SICR)

Company considers a financial instrument defaulted, classified as Stage 3 (credit-impaired) for ECL calculations, in all cases when the borrower becomes more than 90 days past due or classified as non performing asset (NPA) as per RBI guidelines. Classification of assets from stage 1 to stage 2 has been carried out based on SICR criterion. Accounts which are more than 30 days past due have been identified as accounts where significant increase in credit risk has been observed. These accounts have been classified as Stage 2 assets. When such events occur, the Company carefully considers whether the event should result in treating the customer as defaulted and therefore assessed as Stage 3 for ECL calculations or whether Stage 2 is appropriate.



(d) Probability of Default

Probability of default (PD) is an estimate of the likelihood of default over a given time horizon. PD estimation process is done based on historical internal data available with the Company. While arriving at the PD, the Company also ensures that the factors that affects the macro economic trends are considered to a reasonable extent, wherever necessary. Company calculates the 12 month PD by taking into account the past historical trends of the Loans/portfolio and its credit performance. In case of assets where there is a significant increase in credit risk / credit impaired assets, lifetime PD has been applied.

(e) Loss Given Default (LGD)

The LGD represents expected losses on the EAD given the event of default, taking into account, among other attributes, the mitigating effect of collateral value at the time it is expected to be realised and the time value of money. The Loss Given Default (LGD) has been computed with workout methodology. Along with actual recoveries, value of the underlying collateral has been factored in to estimate future recoveries in LGD computation. Workout LGD computation involves the actual recoveries as well as future recoveries (as a part of the workout process) on a particular facility, as a percentage of balance outstanding at the time of Default/Restructuring. The assessment of workout LGD was then performed. Principal outstanding each loan was assessed, which went into the denominator of the LGD calculation. LGD computation has been done for each segment and sub-segment separately.

(f) Exposure at Default (EAD)

The amount which the borrower will owe to the portfolio at the time of default is defined as Exposure at Default (EAD). While the drawn credit line reflects the explicit exposure for the Company, there might be variable exposure that may increase the EAD. These exposures are of the nature where the Company provides future commitments, in addition to the current credit. Therefore, the exposure will contain both on and off balance sheet values. The value of exposure is given by the following formula:

$$\text{EAD} = \text{Drawn Credit Line} + \text{Credit Conversion Factor} * \text{Undrawn Credit Line}$$

Where,

Drawn Credit Line = Current outstanding amount

Credit Conversion Factor (CCF) = Expected future drawdown as a proportion of undrawn amount

Undrawn Credit Line = Difference between the total amount which the Company has committed and the drawn credit line While the drawn exposure and limits for the customer are available, the modelling of CCF is required for computing the EAD

(g) Forward looking adjustments

“A measure of ECL is an unbiased probability-weighted amount that is determined by evaluating a range of possible outcomes and using reasonable and supportable information that is available without undue cost or effort at the reporting date about past events, current conditions and forecasts of future economic conditions.”

To fulfil the above requirement Company has incorporated forward looking information into its measurement of ECL. The objective of developing a macroeconomic model using exogenous macroeconomic variables (MEVs) is to address the requirements of unbiased, probability weighted outcomes while taking into account current conditions as well as future economic conditions. This will be achieved by using the model output to adjust the PD risk component in order to make it forward looking and probability-weighted.

Exogenous macroeconomic parameters were used as independent (X) variables to predict the dependent (Y) variable. The Company formulates base case view of the future direction of relevant economic variable as well as a representative range of other possible forecast scenario. This involves developing two or more additional economic scenarios and considering the relative probabilities of each outcome.



(h) Data sourcing

The Company is expected to obtain reasonable and supportable information that is available without undue cost or effort. Keeping in mind the above requirement macroeconomic information was aggregated from various research database like Economic Intelligence Unit (EIU), Bloomberg, World Bank, RBI database etc. The EIU data has a database of around 150 macroeconomic variables as well as their forecasted values. Beyond 2022 macro-economic variables are forecasted by mean reverting the values to their long term average. External information includes economic data and forecasts published by governmental bodies and monetary authorities in the country, supranational organisations such as the OECD and the IMF, and selected private sector and academic forecasters.

(i) Probability weighted scenario creations:

To incorporate macroeconomic impact into probability-weighted, each scenario has an associated probability. In order to ensure consistency across macroeconomic models, these probabilities were calculated at an overall level for both Retail and Non-Retail portfolios, considering the impact of a scenario across different portfolios may differ based on endogenous factors, the probability of a scenario unfolding is purely exogenous, and hence should not vary.

The Company has identified and documented key drivers of credit risk and credit losses for each portfolio of financial instruments and using an analysis of historical data, has estimated relationship between macro-economic variables and credit risk and credit losses.

Predicted relationship between the key indicators and default and loss rates on various portfolios of financial assets have been developed based on analysing historical data over the past years.

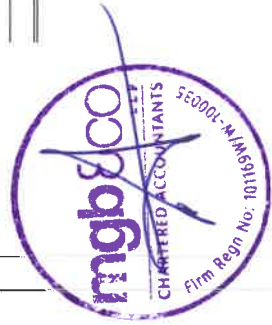

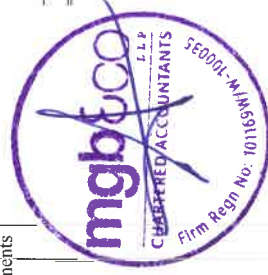

46.3. Market Risk

Market risk is the risk associated with the effect of changes in market factors such as interest rates, equity prices, credit spreads or implied volatilities, on the value of assets and liabilities held resulting in loss of future earnings. The objective of the Company's market risk management is to manage and control market risk exposures within acceptable parameters. The Company separates its exposure to market risks between trading and non-trading portfolios.

Exposure to market risk – Non trading portfolios

Interest rate risk - The principal risk to which non-trading portfolios are exposed is the risk of loss from fluctuations in the future cash flows or fair values of financial instruments because of a change in market interest rates. Interest rate risk is managed principally through monitoring interest rate gaps and by having pre-approved limits for repricing bands.

Asset Liability Management Committee (ALCO) is the monitoring body for compliance with these limits. ALCO reviews the interest rate gap statement and the mix of floating and fixed rate assets and liabilities. Balance Sheet Management Unit is in-charge for day to day management of interest rate risk.

47.1. Fair Value measurement:

A. Valuation principles

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction in the principal (or most advantageous) market at the measurement date under current market conditions (i.e., an exit price), regardless of whether that price is directly observable or estimated using a valuation technique. In order to show how fair values have been derived, financial instruments are classified based on a hierarchy of valuation techniques:

Level 1 – valuation technique using quoted market price: financial instruments with quoted prices for identical instruments in active markets that company can access at the measurement date.

Level 2 – valuation technique using observable inputs: Those where the inputs that are used for valuation and are significant, are derived from directly or indirectly observable market data available over the entire period of the instrument's life.

Level 3 – valuation technique with significant unobservable inputs: Those that include one or more unobservable input that is significant to the measurement as whole.

B. Valuation governance framework –

The Company's fair value methodology and the governance over its models includes a number of controls and other procedures to ensure appropriate safeguards are in place to ensure its quality and adequacy. All new product initiatives (including their valuation methodologies) are subject to approvals by various functions of the Company including the risk and finance functions.

Where fair values are determined by reference to externally quoted prices or observable pricing inputs to models, independent price determination or validation is used. For inactive markets, Company sources alternative market information, with greater weight given to information that is considered to be more relevant and reliable.

The responsibility of ongoing measurement resides with the business and product line divisions. However finance department is also responsible for establishing procedures governing valuation and ensuring fair values are in compliance with accounting standards.

Loans are segregated, as far as possible, into portfolios of similar characteristics. Fair values are based on observable market transactions, when available. When they are unavailable, fair values are estimated using valuation models incorporating range of input assumptions. Group determines fair value of loans with help of internal valuation team and independent valuer on case-to-case basis. Valuation is based on discounted cash flow, comparable transaction market price, market research and marked trend as considered appropriate.

Debt securities

The Company has ensured maintenance of a Liquidity Cushion in the form of cash balance, Liquid debt mutual Fund schemes, bank fixed deposits and undrawn cash credit limits etc. These assets carry minimal credit risk and can be liquidated in a very short period. A comfortable liquidity cushion is maintained of the borrowings. These would be to take care of immediate obligations while continuing to honour our commitments as a going concern.

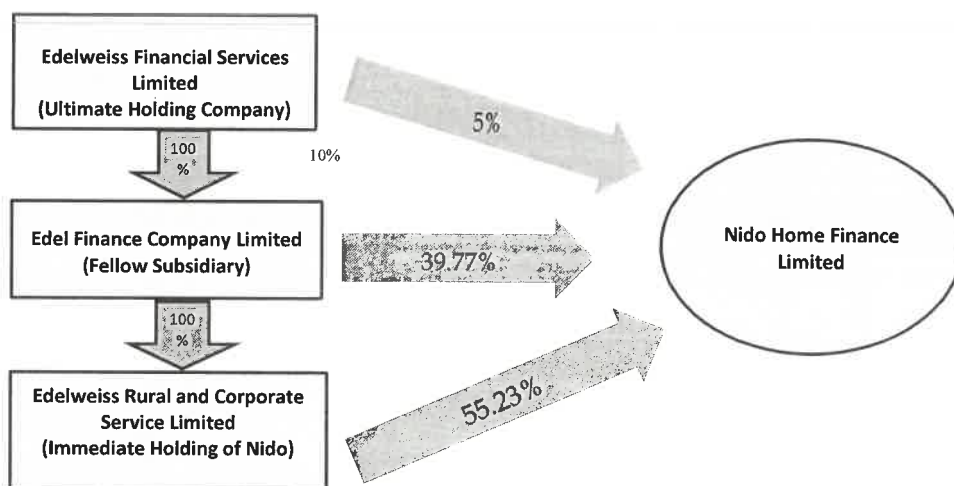
