

SHIVAJI STATUE COLLAPSE

Day after Ajit Pawar’s apology, NCP holds silent protests

TAKING A stand different from its allies which accused the Opposition of playing politics over the Chhatrapati Shivaji statue collapse, the Nationalist Congress Party (NCP) led by Deputy Chief Minister Ajit Pawar Thursday organised a silent protest over the issue.

This comes a day after Ajit Pawar, during a speech in Latur, issued a public apology to people over the statue collapse. The 35-foot statue at the Rajkot Fort in Sindhudurg’s Malvan tehsil collapsed on August 26, nearly nine months after its unveiling by Prime Minister Narendra Modi. In response, the Opposition

MVA has announced a protest march in Mumbai on September 1. Meanwhile, the NCP staged

“self-suffering silent protests” in every district of the state, calling for the installation of a more durable and larger statue of

Shivaji Maharaj at the same site. “In a democracy, everyone has the right to protest. The incident involving Shivaji Maharaj’s statue in Malvan is both unfortunate and distressing. We are also protesting against it and demanding stringent action against the culprits by submitting memorandums to the authorities,” said NCP state unit chief and Lok Sabha MP Sunil Tatkar. The NCP’s protests took place in front of Chhatrapati Shivaji Maharaj’s statues in Chembur and Juhu Chowpatty in Mumbai. Following these protests, the NCP submitted a memorandum to the district collector demanding strict action against those responsible for the statue’s collapse.

Navy-state govt joint technical panel to probe statue collapse

A JOINT technical committee, led by the Indian Navy and comprising representatives from the Maharashtra Government along with technical experts, has been established to investigate the collapse of the Chhatrapati Shivaji Maharaj statue at Rajkot Fort, Sindhudurg. Chief Minister Eknath Shinde announced on Wednesday night that the state government has decided to appoint a committee of civil engineers, experts, IIT alumni, and Navy officers to analyse the reasons behind the statue’s collapse and determine accountability. The CM also instructed the Public Works Department (PWD) to form a new committee of top sculptors, civil engineers, experts, and naval officers to design and erect a grand and fitting statue of Chhatrapati
