### REVERSE RUSSIA OIL WAIVER, ADMIN TOLD

A group of US senators has accused the Trump administration of handing Russian President Vladimir Putin a financial windfall by pausing sanctions on Russian oil exports during a global energy crisis. In a letter to Treasury Secretary Scott Bessent, 13 Democratic senators urged the Trump govt to restore sanctions on Russian oil deliveries and intensify efforts to curb Moscow's energy revenues amid the Ukraine war.

### AIRLINES CUT 13,000 FLIGHTS IN MAY

Airlines have cut 13,000 flights globally in May as jet fuel prices soar. Airlines have removed two million seats from flights over May, new data shows, cuts come ahead of UK half-term holidays at the end of month. Istanbul and Munich have seen largest cut in flights.

### AMERICA SHUTS PESHAWAR MISSION

## Open Strait ASAP, China urges Iran

China on Wednesday called on Iran to reopen the Strait of Hormuz "as soon as possible" as it appreciated Tehran's commitment not to develop nuclear weapons, a prime demand of US President Donald Trump to end the war against the Islamic Republic.

"On the issue of the strait, the international community shares a common concern over restoring normal and secure navigation through the strait, and China hopes relevant parties will respond as soon as possible to the strong call from the international community," Chinese Foreign Minister Wang Yi (R) told his Iranian counterpart Abbas Araghchi in Beijing.

Significantly, Wang appreciated Iran's commitment not to develop nuclear weapons. Trump has been demanding Iran hand over stockpiles of enriched uranium and a 20-year commitment from Tehran not to develop nuclear weapons.

China appreciates Iran's not-to-develop-nuclear-weapons commitment, and affirms Iran's legitimate right to peaceful use of nuclear energy, Wang told Araghchi.

The Iranian foreign minister, who is on his first visit to Beijing after the US-Iran war started, briefed Wang on the ongoing negotiations with Washington to end the war.

"China believes that achieving a comprehensive ceasefire is an urgent priority, while reopening hostilities would be even more undesirable," Wang said. According to the Chinese foreign ministry, Araghchi said, "Priority can be given to promptly resolving the issue of reopening the strait. Iran will firmly safeguard its national sovereignty and national dignity, while continuing to build consensus through peaceful negotiations and seek a comprehensive and lasting solution."

Separately, the Iranian and Saudi foreign ministers discussed regional developments over the phone on Wednesday, stressing on the need to continue diplomatic efforts and regional cooperation to avoid renewed tensions, according to the Iranian foreign ministry.

Meanwhile, Pakistan PM Shehbaz Sharif thanked President Donald Trump for announcing a pause in the operation in the strait.

# US presses China over Iran support

US Secretary of State Marco Rubio stepped up pressure on China and Russia over the strait crisis, warning countries helping Iran evade sanctions could face economic consequences from the US.

At a White House briefing, Rubio said the Trump administration was preparing a renewed push at the UN while warning Beijing its economic interests were being harmed by Iran's actions in the Gulf.

"We're going to the UN," Rubio said. "We're going to give it another chance to be a forum in which we're not even asking the region to commit troops to the people. All we're asking them to do is to condemn it, to remove these mines, and to allow humanitarian relief to come through," he said.

The secretary described the crisis as a test of the credibility of the UN system. "These guys (Iranians) are bombing commercial vessels," Rubio said. "They're not bombing naval vessels; they're bombing commercial tankers."

Rubio warned foreign financial institutions and companies helping Tehran bypass sanctions could face secondary sanctions.

Rubio addressed the growing relationship between Beijing and Tehran. "I hope the Chinese tell him what he needs to be told, causing you to be globally isolated," Rubio said. "That what you were doing in the straits is causing you to be globally isolated."

The secretary of state argued China's export-driven economy would also suffer if instability in the strait disrupted global trade flows.

"It is in China's interest that



Iran stop closing the straits," he said. "It's harming China as well." Rubio defended Trump's authority to conduct military operations against Iran without congressional approval, calling the War Powers Act "100% unconstitutional." "That has been the position of every single presidential administration since the day that law passed."

Rubio said major US military operations against Iran are over — but he stopped short of saying the conflict cannot be rebegun. "Operation Epic Fury" "is concluded" as its objectives were met.

Rubio said recent clashes with Iran related to US efforts

to reopen the strait were "defensive in nature." "We're not cheering for an additional situation to occur," he said.

"At least 10 sailors have already died as a result." The sailors come from 87 countries and are innocent bystanders. Further, Rubio described Hezbollah as the main obstacle to lasting peace between Israel and Lebanon.

Meanwhile, Pope Leo called out Trump's misrepresentation of his views on Iran and nuclear weapons. Leo said the Catholic Church "for years has spoken out against all nuclear weapons, so there is no doubt there."

Trump again accused Leo in an interview of being "OK for Iran to have a nuclear weapon." Leo has said no such thing, and Catholic Church teaching says the mere possession of nuclear weapons is "immoral."

## Russia snubs Kyiv's unilateral truce, fire drones

Kyiv: Russia fired dozens of drones at Ukraine in nighttime attacks, Ukrainian officials said on Wednesday, disregarding a unilateral ceasefire announced by Kyiv that began at midnight. Defence Ministry claimed Ukraine hadn't abided by its own ceasefire.

Meanwhile, a shipment of Ukrainian cash and gold worth \$82mn Hungary seized earlier in 2026 has been returned to Oschadbank, President Volodymyr Zelenskyy said. —AP

# PIO Nithya Raman shakes up Los Angeles mayor race

Born in Kerala in 1981, Nithya Raman moved to the US as a child and has since built a career at the intersection of policy and community work. She currently serves as the councilmember for Los Angeles' District 4, a role she took on in 2020 after a breakthrough electoral win.

Her victory marked a milestone. She became the first Asian American woman and the first South Asian to sit on

the Los Angeles City Council. Raman's political outlook is deeply informed by her academic and grassroots background.

She studied at Harvard University and later completed a master's in urban planning from Massachusetts Institute of Technology.

Before entering electoral politics, she co-founded the SELAH Neighbourhood Homeless Coalition, working

directly on homelessness, an issue that remains central to her platform.

Raman entered the 2026 LA mayoral race hours before the filing deadline in Feb. The decision raised eyebrows, because she had previously backed sitting mayor Karen Bass.

Observers increasingly likened Raman to Zohran Mamdani, a prominent progressive voice in US politics.



## Trump revives fitness test in US schools

Washington: US President Donald Trump revived the Presidential Physical Fitness Award as part of his push to return an annual physical fitness test to America's schools.

The award is tied to the Presidential Fitness Test, which was a public-school fixture for decades but was phased out under Barack Obama in favour of a programme that minimised competition and focused on long-term health. Trump signed an order last summer to reestablish the fitness test, created in the 1950s. "We're bringing it back," Trump said at an Oval Office ceremony alongside kids and professional athletes.

# Iran to use 'kamikaze dolphins' to attack US ships in Hormuz?

Washington: Amid continued concerns over Iranian mines disrupting the shipping in the strait, US Secretary of Defence Pete Hegseth fielded questions on whether Tehran might turn to "dolphins" to confront the US Navy in the war in West Asia. The idea isn't very far-fetched, it seems, as several nations, including the US, have reportedly used "kamikaze dolphins" in conflict areas in the past — though not as weapons.

Hegseth dismissed the idea, saying he could "confirm" Iran didn't have dolphins to deploy as part of operations but said he would neither "confirm nor deny" whether the US had kamikaze dolphins.

The idea was first reported by the Wall Street Journal on April 30, with an article claiming Iranian officials had said Iran could use "mine-carrying dolphins" to attack US war-



ships. It is not clear whether Iran has that capability.

The US Navy has a decades-old programme to train dolphins to detect mines. The US Marine Mammal Programme is part of the Intelligence, Surveillance, and Reconnaissance Department within the Naval Information Warfare Centre Pacific. But the dolphins trained by the US are not kamikaze dolphins, meaning they do not sacrifice their lives to detonate mines.

Instead, they're focused on detection. However, citing a source, CNN reported the US military isn't using dolphins as part of its efforts to reopen the strait. —Agencies

## New system to regulate traffic

Tehran: Iran has launched a new system to control ship traffic through the strait, state media reported, continuing a maritime standoff that now involves a US blockade and threats of military action. Under the new rules, all ships planning to pass through the narrow waterway must receive permission via email from Iranian authorities, according to state-run Press TV.

Iran is calling the initiative a "sovereign governance system." Ships would be required to adjust their operations accordingly and obtain permission before entering the waterway, Press TV reported. It described the initiative as a "sovereign governance system" now in effect in the strategic chokepoint. —Agencies
